RCA – Appeal of Rejection of Application for Safety and Training Specialist – Lauren Facer (EP)

Ms. Facer has appealed the rejection of her application for Safety and Training Specialist (Public Service) for not meeting the CDL requirement. Based upon the information provided, Staff recommends that the Commission deny Ms. Facer's appeal and uphold the rejection of her application stating she does not possess a Class B Commercial Driver's License as stated in the job announcement for the position of Safety and Training Specialist (Public Service).

Mr. Comes' has appealed the rejection of his application for Safety and Training Specialist (Public Service) for not meeting the education requirement. Based upon the information provided, Staff recommends that the Commission deny Mr. Comes' appeal and uphold the rejection of his application stating he does not meet the education requirement for the position of Safety and Training Specialist (Public Service).

After review and discussion, the Commission denied Mr. Comes' appeal and upheld the rejection of his application for not possessing an Associate's Degree as stated in the job announcement for the position of Safety and Training Specialist (Public Service).
